To qualify for JSP grade 12, an individual must have one year of legal work experience. To qualify for JSP grade 13, two years of legal work experience is required. Except for JSP grade 11, a bar membership is required.

LEGAL WORK EXPERIENCE: Legal work experience is defined as progressively responsible experience in the practice of law, in legal research, legal administration, or equivalent experience received after graduation from law school. Major or substantial legal activities while on military duty may be credited on a month-for-month basis whether before or after graduation, but not to exceed one year if before graduation from law school.

COURT PREFERRED SKILLS:

- Experience in the subject area of social security disability law.
- Prior clerkship experience.
- Graduation from law school with a cumulative GPA of 3.5 or higher.
- Excellent legal research, writing, and communication skills.

BENEFITS: Employees of the Federal Judiciary are entitled to federal employee benefits including health, dental, vision, and life insurance programs; paid leave; periodic grade and step increases; and paid holidays. Conditions of Employment

- Applicants must be a citizen of the United States or eligible to work in the United States.
- Employees are required to adhere to the Code of Conduct for Judicial Employees, which is available for employees and applicants to review upon request.
- Judicial employees are subject to periodic Federal Bureau of Investigation (FBI) background checks.
- Employees of the United States District Court are excepted service appointments and are not classified under Civil Service.
- Excepted service appointments are at will and can be terminated with or without cause by the Court.
- Travel and relocation expenses are not reimbursed.
- Employees are subject to mandatory electronic funds transfer for payroll deposits.
